Entries by fax and/or mail shall be binding. Entries and stable reservations will not be handled before receipt of payment.

**Participation**

Entries will not be considered unless forms are completely filled in and received by the organizer in due time, accompanied by horse documentation (AQHA, APHA, etc.) including NRHA Competiton License, a copy of the valid NRHA membership card (presenter and owner), and evidence of payment of all fees. Permission to take part will not be given unless a valid membership card of the NRHA is presented on the day of the event, regardless of whether a membership card exists and is valid at the time of the event.

**Withdrawal and Non-participation**

The entry fees, in principle, will not be reimbursed if a participant calls off after entry. Upon submission of a veterinary report (specialist in horses), up to 50 % of the entry fee may be reimbursed, but only up to one week before the beginning of the event. Entry fees become due for payment also in case of non-participation and may be called in even after the end of the event, if necessary.

**Changes**

The organizer reserves the right to change the invitation up to the closing date for entries, to relocate (postpone) the event upon agreement with NRHA, or to cancel it, returning any stakes made, if circumstances so require.

**Recognition of organizer's conditions**

With the entry and coming into the grounds of the organizer, every participant and horse owner shall submit to the organizer's instructions and orders and recognize the rules of the NRHA.

**Doping tests:**

The treatment of horses with foreign substances or drugs, that are not allowed according to the doping laws of Germany, are prohibited. All horses are subject to testing during the NRHA European Futurity. Upon discovery of the existence of prohibited surgery or injection of foreign substances or drugs, the horse will be disqualified immediately. Paid prize money has to be paid back and/or special prizes have to be given back to the Eventomania.

**Ribbon presentation:** Price money will be paid only if the rider shows up at the ribbons presentation with the horse. The price money checks have to be picked up after the ribbons presentation or before the lunch break of the following day at the show office. The checks have to be cashed in six month after the NRHA European Futurity 2010, after which they expire. Price money paid for horse not in German ownership, are subject to tax deduction for price money according to the German tax law.

**Payment of prizes and Reimbursements**

The organizer is entitled to deduct any outstanding financial commitments of participants and horse owners. For foreign horse owners, this applies also to the withholding tax according to § 50 a, para 4 of the Income Tax Law. After deduction of the VAT from the prize money, the following withholding tax rates will be due: 0 % upto 250 €, 10 % up to 500 €, 15 % up to 1.000 €, 20 % above 1.000 €, plus 5.5 % solidarity surcharge on the amount of the withholding tax. The tax deduction will have to be confirmed, if requested. Those foreign participants who are exempt from tax deduction are asked to submit a notice of nonliability for tax together with the application for entry, or on the first day of the event, at the latest. Participants themselves are responsible for the complete and proper indication of all the necessary data. Foreign currencies will not be accepted. Every rider himself is responsible for his starting.

**Place of jurisdiction**

The place of jurisdiction shall be Ingolstadt. Disputes shall be decided by the courts having competence for the place of business of the Eventomania.
